WAIVER and RELEASE

I accept full responsibility for the conduct of each member of my crew and guests during the 2010 Shields Class Sailing Association National Championship Regatta (the "Regatta"), post race activities and acknowledge responsibility for the safety of my crew and yacht.

MIYC officers, trustees, the Shields Class Sailing Association officers and Governing Board, Shields Class Fleet 19 officers and members, Race Committee members, Protest Committee members, volunteers, club members, sponsors, or any other organization or officials, (the "Race Organizers") are not responsible for accidents, damage or injury to property or to yachts, crew or guests arising from any cause during or related to any race or activities of the Regatta.

I and my crew will evaluate the weather and sea conditions and are responsible for determining whether it is safe for us to participate and continue participating in the regatta. The responsibility of wearing life jackets rests entirely upon me and my crew. If assistance is provided by anyone representing the Race Organizers, I and my crew will not hold any of them responsible for any injury, death or damage resulting from their actions to assist us.

My yacht will be outfitted, equipped and handled in accordance with these conditions; she will have all of the required and necessary equipment aboard; she is seaworthy in hull, rig and gear; and she will be completely manned.

- 1. My crew and I recognize that sailing is an activity that has an inherent risk of damage and injury associated with it. We have read RRS 4, Decision to Race, and hereby acknowledge and agree that we are participating in this event entirely at our own risk.
- We acknowledge and agree that none of the Race Organizers will be responsible for:

 (a) any damage to my yacht or my other property, or
 (b) any injury to me or my crew, including death, sustained as a result of the participation of me, my crew and my yacht in this event.
- 3. I hereby waive any rights I may have to sue the Race Organizers with respect to personal injury or property damage suffered by me or my crew as a result of our participation in this event and hereby release the Race Organizers from any liability for such injury, death or damage to the fullest extent permitted by law.
- 4. I have taken all necessary steps to ensure that I, my crew and my yacht are adequately prepared for all possible contingencies, including appropriate safety equipment as may be required by law, USCG regulations or that a prudent seaman would consider advisable.
- 5. I understand this document has important legal consequences and have consulted such legal and other advisors, as I deem appropriate before signing below.

In consideration of being permitted to participate in the Regatta, I, my executors, administrators, heirs, next of kin, successors, and assigns, waive, release and discharge any and all claims, actions, causes of action and suits whatsoever, in law, admiralty or equity, that they may have against the Race Organizers or their executors, administrators, heirs, next of kin, successors, or assigns, including any or all claims for damage caused by the negligence of any of them arising out of my participation or that of my yacht in the Regatta and its related activities, including pre-start and post finish operations and shore activities together with any costs and expenses including attorney's fees that may be incurred as a result of any such claims that I, any crew member, or any guest (or their executors, administrators, heirs, next of kin, successors, or assigns) may have or assert together with any costs and expenses including attorney's fees that expenses including attorney's fees with respect thereto.

I, MY CREW MEMBERS AND GUESTS HAVE CAREFULLY READ THIS WAIVER. WE UNDERSTAND AND AGREE TO ITS CONTENTS. WE HAVE KNOWINGLY EXECUTED IT FOR THE PURPOSES RECITED THEREIN.


