1) President's Report: Eric Anderson

5) Discussion Topics

Ocean Great Lakes Challenge Review

- Peter reported that Fleet One was supportive of potentially holding the event and that discussions were now underway with Larchmont YC and the Race Committee.
- Eric noted that there was no need for a decision now, with October being a good time for decision making.

2016 National Regatta: Garth Hobson/Eric Anderson

- NOR has been published. SIs will likely be released in early September, 3 weeks before the
 event.
- Focus has been on race course, much of which is over deep water (170 ft), in order to get legs
 and courses of the required distance, and to get away from the kelp. Team has been
 experimenting with how best to hold the marks in this depth.
- Richard asked whether previous Nationals had been held in locations which did not comply with distance requirements, thought Dallas was likely where the lake was narrow.
- Eric and Garth commented that: a) they were aiming to be compliant with the Nationals rule and b) they would definitely set courses away from the kelp.
- Question was asked about why the course has to be so far out, so deep?
- Eric and Garth responded that it was about a) getting far enough out to have long legs and b) far enough from the landmass so that local knowledge would not be a factor. They did a trial race two weeks ago which ended up with a 5 mile course (not yet a 6 mile) and the trial went well. "Still a few things to iron out though".
- Garth comments on status:
 - o Signups:
 - 13 signups, 8 out of town, 5 local.
 - Have 16 Shields available, plus 1 on hard, 1 in Marina del Rey
 - Looking for 4 more sign ups, which will be given priority to out of towners, then the local fleet.
 - Housing: should be able to accommodate everyone.
 - Social events will be great.
- Eric: reported that a spectator boat had been set up for Saturday which was meant for people from club, fleet, military and spouses. Pricing to be figured out.

2017 Nationals Regatta - Mystic
