President's Report, Eric – Paul McKinnon, nominating committee chair, with Pete Seigl, and Skip McGuire proposed Ken Deyett, President; Garth Hobson, Measurer (transition until second year with Eric supporting in first year); Steve Mettler, Secretary; Jay Dayton, Treasurer; Ted Slee, VP; Doug Millar, VP replacing Pete McWhinnie; John Gronberg, VP, replacing Chris Wick; Tom McManus, VP; Sam Vellieux, VP; Ron Oard, VP; Rich Robbins, webmaster; and Eric Anderson, communications (eMasthead) Richard proposed motion to accept slate as proposed from nominating committee, Eric seconded. End of August eMasthead. Update on regional regattas.

One waiver requested from fleet 10. Sam Goodwin owns 248. Sailed in Fleet #10. He is a good sailor but has not met the 10 race requirement. Waiver requested so he can sail in the Nationals. Richard proposed, Ken seconded. All in favor. Motion passes.

Measurer's report, Kim – Not present. Ken and Richard went to Cape Cod to look at the masts. Nine new masts are received, prior to tapering and anodized. All the masts met the dimensional requirements.
