b. Simplifying Masthead Distribution

- i. Bob Bannis and his daughter have simplified layout and worked with laser letters to reduce expense to produce. If we sent to fleet captains only instead of individuals, it would reduce costs to \$650.

  - a. No Update
- 4. Committee to Improve National Regatta Attendance Ken
  - a. NRAC Meeting Minutes from February 5, 2018 and National Regatta Attendance Graph, 2007-2017 distributed to committee – Ken
  - b. Attendees included 106 skippers, 8 different venues, 33 skippers traveled (call list for future regattas)
  - c. Survey Monkey showed that a change in format to Friday/Saturday/Sunday will help and this is what Chicago is doing
  - d. Open to other ideas
  - e. Communication and promotion is important which lead to a discussion on preparing a Masthead light version
    - i. Content has always been the main issue. It should include a president's column, Measurer report, tuning/fixing tips, and trailering boats tips
    - ii. Email is best and has replaced blogs
    - iii. Target a Spring and August distribution
    - iv. Larchmont has twitter page, instagram and facebook. Facebook group is used most but not much content Doug
    - v. Newport uses many different approaches and recommended better using class facebook, but frequent input is needed to keep active Ted
    - vi. Need to be careful not to overload emails Ken
    - vii. Email is best but keep some social media like posts made to facebook can be linked to class website, Class Facbook site, Fleet 9 Facebook site Jay

- viii. Newport uses a weekly fleet email and has open rate of 70%. This includes relevant information like course changes and warnings. Ted
- ix. Proposed wrapping up next month, but committed to targeting an April 1<sup>st</sup> (August) email for a Masthead light with mail chimp. - Eric
- x. Email any ideas to Ken or welcome join NRAC meetings for discussions Ken

- 5. 2018 Great Lakes Challenge Ted
  - a. NOR draft and final entry form distributed
  - b. Grant is being applied from State of RI
  - c. John Burnham and Ted Slee are co-chairs
  - d. 9 boats are signed up
  - e. A request was made to change S2.2 to modify the 10 race minimum rule (calendar year starting January 1) Eric
  - f. Be careful making exceptions. It is a good rule and we had issues in the past Bill
  - g. Honor is important and should have some flexibility, maybe at discretion of fleet captains and/or national committee to increase participation if needed.
  - h. Corny's concept Bill
  - i. NOR to be finalized
- 6. 2018 National Regatta, Edgartown Steve
  - a. Making preparations, registration is open, looking forward to a great event
- 7. 2019 National Regatta, Chicago Eric
  - a. To get 18 boats, 10 will need to travel as fleet has 11 hulls of which 9 are raced
  - b. Stipend for travel was available in the past, \$250/boat
  - c. Stipend for >500 miles was \$325/boat and there is precedent Ken
- 8. New Business
  - a. 'New England Championship' applied to Buzzards Bay Regatta Bill
    - i. Rich will push on website when he returns from New Zealand
  - b. Smaller spinnaker as used in Marion may need acknowledgement by National Committee and/or amendment to class rules – Bill
    - i. Better idea in long run
    - ii. Used in Marion for last 10 years, sharing 5 amongst fleet
    - iii. Discussed this previously in Larchmont in 2014. It is going on in practice and need to put on notice board. Eric
