 - iii. Skipper(s) must meet the 10 race class rules and become members of class.
 - iv. Max number of two participants at \$750 each. Stipends will be awarded on a first come basis.
 - v. First two registered Skipper approved by the National Board will be awarded a check for \$750 at the Skippers Meeting.
 - vi. Twenty-Something Grant Program eligible crews must bring their own boat.
 - vii. Maximum possible cost to class \$1,500
 - c. Newcomer Grant Program- The Newcomer Grant Program will give a \$500 discount to the Newcomer registered and paid in full for the Nationals. This will encourage a Shields Corinthian Sailor to attend the Nationals. Proposal Guidelines as follows:
 - Newcomer will be defined as a class member competing in his first Shields Nationals. Never having crewed or skippered in a Shields National Event.
 - ii. The Grant will be given to the first 2 registered new Shields skippers for the Nationals that have paid in full.
 - iii. Newcomer Grant eligible skippers must bring their own boat.
 - iv. The class will make the final decisions and present \$500 check at the Skippers Meeting.
